

Purpose:

To seek the appointment of the four (4) Independent Members to Council's Development Assessment Panel (CDAP) recommended by the interview panel.

Summary - Key Issues:

Council's CDAP term for Independent Members will come to an end on 26 March 2011. Due to the end of the term Council is required under Section 56A of the Development Act 1993 to appoint Independent Members to the Panel at this meeting.

Recommendation:

That having considered Agenda 16.1, in confidence under 90(2) and 3(a) of the Local Government Act 1999, the Council pursuant to Section 91(7)(b) of the Act orders that the documents and all minutes be retained in confidence until 26 March 2013 and that this order be reviewed every 12 months.

Background:

- A confidential memo will be sent to the Elected Members prior to the Council Meeting (4 April 2011) with the CVs of the short listed candidates. The contact details will be blanked out for privacy. The CVs will need to be collected following the meeting.
- 4. Section 56A of the Development Act 1993 requires that a Council must establish a Development Assessment Panel (DAP) to exercise or perform its development assessment powers and functions under the Development Act 1993. This involves the assessment of development (planning) applications, enforcement of conditions of approval or breaches of the Act and also informing Council of any perceived deficiencies in the Mount Barker (DC) Development Plan.
- 5. The CDAP is an independent decision making body that currently meets every third Wednesday and the CDAP determines approximately 2% of development applications submitted to Council with the remainder being determined by staff under delegation. Those applications considered by CDAP generally comprise the most significant and complicated applications submitted to Council.
- 6. Council has had the CDAP consisting of 4 independent members and 3 Council Members since December 2006 in response to the revised provisions of the Development Act 1993.

- 7. The Council at its meeting of 17 January 2011 appointed three (3) Council Members to fill three (3) of the positions on the CDAP consisting of the following:
 - Councillor Gamble
 - Councillor Irvine
 - Councillor Stokes
- 8. Council staff placed an advertisement in the 'Advertiser' and the 'Courier' in January for an Expression of Interest for Independent Members of the District Council of Mount Barker DAP. In response to the advert, Council received eleven (11) applicants which was short listed to six (6) applicants.
- The Council at its meeting of 17 January 2011 appointed three (3)
 Council Members to an Interview Panel, in addition to one (1) member
 of staff, for the selection of the proposed Independent Members of the
 CDAP which are as follows:
 - Mayor Ferguson
 - Councillor Bailey
 - Councillor Westwood

Discussion:

SELECTION PROCESS

- 10. Council staff has undertaken the below process in seeking independent members for it's CDAP.
- 11. Public call for expression of interest through an advertisement in a State-wide and local newspaper that outlined the role of the Panel and Presiding Member, skills, experience and qualifications of interest, outlining that members would be compensated for their time;
- 12. Eleven responses were received to Council's advertisement seeking expression of interest for Independent Members of the CDAP.
- 13. Candidates were short-listed against a set of consistent criteria by Council's two (2) Senior Planners, Judith Urquhart and Randall Richards.
- 14. The three (3) Council Members and a member of staff (Senior Planner Randall Richards) held interviews of the six (6) short listed applicants on 8th, 9th, 10th and 11th of March 2011.
- 15. The candidates in their response to the Expression of Interest, made their intensions clear whether they were applying for the Presiding Member role or the Independent member role. Three (3) candidates

indicated an interest for the Presiding Member role. To ensure the appropriate selection of the Presiding Member role was fulfilled, one the question asked at the interview was, "Would you be prepared to be a member, presiding member, preference?" A copy of the interview questions are in Appendix 2.

- 16. One (1) of the short listed candidates (Stephen Smith) pulled out of the interviews prior to the scheduled date, the interview panel agreed to interview the next candidate in line (Geof Nairn) from the list of candidates.
- 17. Consideration was given to the structure and operation of the CDAP with the intention to have a panel which has a mix of skills and backgrounds and members who have direct experience in the operation of DAP's or similar type committees.
- 18. However, should Council be uncomfortable appointing the selected Independent Members, additional advertisements may be required. In addition, the current term of the Independent Members will need to be extended until May 26 2011 to allow sufficient time to re-advertise and select members.
- 19. All persons selected as Independent Members will individually present a professional discipline to the CDAP, which when combined will deliver, in conjunction with the Elected Member representation, a complete and balanced decision making body to guide development in the District.
- 20. The Development Act 1993 has no performance criteria for the members of the CDAP however, the minutes of the meeting will indicate an attendance record.

From 1992 I was Project Manager of a large contaminated site, which was rehabilitated for residential development. I am familiar with the complex processes involved in clean up and certification requirements of contaminated land. The Burley Griffin Estate at Brompton (formerly the Hindmarsh Council Depot and Readymix Concrete Wash Down sites comprising about 20 acres of waste industrial land) developed by the Trust was one of the first large residential redevelopment projects requiring extensive remediation undertaken in this State. I led the team which undertook the planning and engineering design, engineering remediation and

environmental certification from the Department of Environment and Natural Resources for residential use.

During that time I was seconded to head up and implement a revised staffing structure for the Disability Pensions Section, which was responsible for assessing new disability pension applications and applications for increase in disability pension.

Northern Territory Government:- 1971 to 1980. I was a senior planner in the Northern Territory based in Darwin with the Commonwealth and later, State Governments and for 5 years during that period was the Town Planner for the whale of the Northern Territory.

This work included town planning design for new residential areas in all the major towns through the Territory (including the major centres of Darwin, Katherine, Tennant Creek and Alice Springs), including area planning, shopping centre and school locations, major road links, subdivision allotment design for new suburbs, community facilities provision and open space reserves, providing Executive Officer services to the Northern Territory Town Planning Board which was responsible for the administration of the authorised Town Plans for the whole of the Northern Territory, assessing development applications and making recommendations to the Town Planning Board for approval with appropriate conditions and framing appropriate development conditions for Government land releases for residential, commercial and industrial use by the private sector.

When the Tarcoola to Alice Springs rail line was being converted to standard gauge, a Federal Government inter-Departmental Committee was established to consider and recommend the location of the new Alice Springs Rail Terminal. I was the Town Planning representative appointed to the Committee to investigate the land use implications of the competing needs of Alice Springs town centre development and rail terminal location. I wrote a major planning report on the Alice Springs Rail Terminal siting options on behalf of the Department of Northern Territory as part of my responsibilities on the Inter-Departmental Committee.

I was also the Town Planning representative on the Ayers Rock Advisory Technical subcommittee set up to investigate and recommend to the Northern Territory Government, the site selection of the current Ayers Rock Village and air strip, now known as Yulara, prior to the Commonwealth Government taking over responsibility for final design and development of the selected sites.
