Purpose:

To provide an update on the debt of Hillgrove Resources and options for a disposal path for Council's treated wastewater (recycled water) beyond the current Hillgrove Resources open cut mining operation.

Summary - Key Issues:

- Hillgrove Resources has continued to make regular payments to Council for recycled water supply, with the amount received in October 2018 being \$192,509 and represents a very significant increase compared to previous months;
- Hillgrove Resources is continuing to pursue the possibility of a Pumped Hydro Energy Storage; and
- With the planned cessation of open cut mining by Hillgrove Resources in mid 2019, Council needs to establish a secure disposal path for a steadily increasing supply of recycled water.

Recommendation:

That Council:

Background:

- The debt of Hillgrove Resources to Council for the supply of recycled water is a long standing issue and the numerous previous agenda items remain the subject of confidentiality orders via Council meeting resolutions.
- 2. This item is the result of the resolution at the Council meeting held on 7 May 2018.
- 3. On 12 October 2018 Mr Steve McClare, Chief Executive Officer and Managing Director of Hillgrove Resources met with Mr Stuart and Mr Clancey.

Discussion:

Debt Position

- 4. Since earlier this year, Council has applied interest to the overdue amounts. Trading terms are that payment is to be made in 30 business days.
- 5. Payments to Council by Hillgrove Resources continue to be made regularly.
- 6. In the month of October the amount received from Hillgrove Resources was \$192,509 which is a very substantial increase compared to previous months with the average payment per month over the previous 6 months being \$42,149.
- 7. The position as at 29 October 2018 is summarised in the table immediately below.

- 8. By way of comparison in February 2018 the total debt was \$333,646 and of that 25% being \$82,501 was 90+ calendar days.
- 9. Mr McClare again spoke positively about cash flow improvement and the intent of Hillgrove Resources to return to meeting trading terms to all creditors in the short term future.

Pumped Hydro Energy Storage (PHES)

- 10. Mr McClare sought a further letter from Council (attached) to be provided to Hillgrove Resources for the express purpose of it being made available by Hillgrove Resources to the small number of companies short listed by Hillgrove Resources and invited to provide them with a firm proposal for a PHES.
- 11. Understandably, these companies are seeking very long term contracts regarding water supply given the very significant up front capital investment that would be required to be made by them and the associated return on investment sought over an extended period of time.
- 12. Mr McClare indicated that the aim of the Hillgrove Resources Board was to promptly bring this process to a conclusion. Should a PHES not proceed the intent of Hillgrove Resources is to transition from open cut to underground mining. This would see the demand for water reduce significantly, potentially by around one third.
- 13. Should a PHES proceed this may have very significant implications for Council in relation to finding a long term disposal path for recycled water (both initially and subsequently to replace losses via evaporation) and an associated revenue stream.

Mine Site Tour

- 14. Mr McClare offered a tour of the mine site for Council Members with commentary as to what is proposed to occur where and when on site, both with or without a PHES proceeding.
- 15. First hand exposure to the mine site in this context would be valuable for Council Members to increase understanding pre decision making.
- 16. Other site tours are also planned for Council Members post the current elections.

Community Engagement:

Policy:

Budget:

The 2018/19 budget has a budgeted revenue of \$650k associated with the sale of recycled water. The revenue from sales to Hillgrove represents 95% of this budgeted revenue. As at 30th September 2018 a total of \$153k of Recycled Water sales has been invoiced to Hillgrove for the 2018/19 financial year.

Statutory/Legal:

Water Supply Agreement between Council and Hillgrove Copper Pty ltd.

The EPA licenses Council for the operation of the wastewater treatment plant on Springs Road and a disposal path for treated wastewater. Health SA is the regulatory body in respect of the use of recycled water.

Staff Resource Requirements:

The recommendations can be implemented within existing staff resource capacity.

Environmental:

An objective is to maximise the use of recycled water. Usage by Hillgrove (and other recycled water customers) enables a productive disposal path for treated effluent.

Social:

Hillgrove Resources continues to be both a major employer and a significant purchaser/consumer of goods and services with implications for many contractors and other businesses.

Risk Assessment:

The major risks to Council are that:

- a. Hillgrove Resources defaults on the payment of the debt and being unsecured, Council has no avenue for recourse and the debt will have to be written off; and/or
- b. Hillgrove Resources ceases taking recycled water from Council earlier than the current forecast of the open cut mine operation ceasing and Council then needs to action an alternative disposal pathway and manage the associated implications; and/or
- c. Council does not secure an alternative disposal path for treated wastewater in the timeline required.

Asset Management:

Council owns and is responsible for the pipeline that supplies recycled water to the Hillgrove Resources mine and extends to the town of Callington.

Conclusion:

Council needs to continue to regularly monitor payments from Hillgrove Resources for recycled water and the associated amount of the debt, and the pursuit by Hillgrove Resources of a Pumped Hydro Energy Scheme.

RE: Recycled Water Supply - Pumped Hydro Energy Scheme

I am writing further to my letter to you of 4 April 2018.

Council is aware of subsequent actions by Hillgrove Resources to pursue a Pumped Hydro Energy Storage (PHES) Project through your confidential briefing to Council Members at Callington.

Council has a policy objective to secure 100% use of recycled water, as generated from Council's wastewater treatment plant and storage facility.

The current total supply capacity of Council of recycled water is around 1,200 mega litres per annum. With the significant population growth in Mount Barker that under existing zoning is anticipated to continue for the next 35+ years, this supply capacity will steadily increase each year.

Council is seeking to secure long term certainty for a disposal path and the productive use of recycled water.

Given this growth there is confidence as to the future supply capacity. Council will consider approaches for large scale, long term use of recycled water. Subject to suitable risk and reward, and terms and conditions, that may involve consideration of a term of around 50 years. This could be on similar commercial terms to the current Hillgrove Resources contract where funding of the required distribution infrastructure was the responsibility of the customer and price is indexed annually.

Council is yet to be informed as to the water quality that would be required. The current quality provided by Council is log 5 (notionally class A). If the PHES requires a higher or lower quality the capital and recurrent cost implications of that change would need to be identified and negotiated.

As you are aware, Council has recently invested in upgrading a section of the current distribution pipeline that was constructed by Hillgrove Resources several years ago and is owned by Council and enables the supply of recycled water to the mine and other customers.

Council has a Strategic Partnerships Policy and a Commercial Policy. This policy framework signals that Council is open to considering a strategic partnering relationship other than simply the conventional service provider and customer relationship.

Council would also welcome the investigation of potential third party revenue opportunities from recycled water through the secondary use of the PHES as a source of storage for distribution to enable primary production use. Recent research commissioned by Council has indicated a demand for this in the vicinity of the Hillgrove Resources mine.

I look forward to further communication with you on these opportunities.
