PURPOSE

To provide an update on the Morphett Street stormwater upgrade and soil contamination.

BACKGROUND

Further to the information provided in the agenda item for the special meeting of Council held on 24 September 2008 and the most recent of several Memos to Council Members dated 2 February 2009, the following update is now provided.

DISCUSSION

Stormwater Works

The upgrading works have recently been completed and the new stormwater infrastructure is now functional. The works were completed within the revised budget approved by Council.

Importantly the capacity of the stormwater drainage has been significantly increased and all of the infrastructure is now located on council land ensuring accessibility as and when required.

Soil Contamination

Despite Council officer negotiations with representatives of Gilbert Motors, no admission of liability or other proposal has been forthcoming as yet from Gilbert Motors regarding the soil contamination encountered during the construction works.

Council has recently written to the Chief Executive Officer of the Environment Protection Authority (EPA) seeking a meeting to discuss what role the EPA would be prepared to play, particularly given new soil contamination legislation comes into effect on 1 July 2009 providing the EPA with greater powers in this area.

Council has communicated with the EPA previously. To this point the EPA has been helpful in terms of council resuming the infrastructure works but very passive regarding the contamination source itself.

Total costs to Council for the soil contamination are now exceeding \$0.4 million.

Tonkin Consulting Dispute

Tonkin Consulting undertook the design of the stormwater infrastructure upgrade.

Council wrote to Tonkin Consulting in late 2008 indicating that they had very significantly underestimated the cost of relocation of services and failed to fulfil some requirements of the project brief relating to this, resulting in a significant financial impact on Council.

This impact would have been much greater had Council officers not contributed to re-design work of the stormwater infrastructure to minimise conflicts with existing other services.

A response from the Chief Executive Officer (CEO) of Tonkin Consulting regarding the dispute as to the performance of Tonkin was recently received, almost six months since Council wrote.

Council has recently sent a further letter to the CEO of Tonkin Consulting to express extreme disappointment with both the delay and content of their response, and advise that we are now seeking legal advice.

Instructions have been issued by Council to Thomson Playford Cutlers (TPC) regarding possible legal avenues and the associated implications.

TPC has sought some further information from Council which is in the process of being provided. Following this it is anticipated that the TPC advice will be provided to Council without delay.

With the benefit of the TPC advice, Council can then determine what action it wishes to undertake regarding Tonkin Consulting.

Council has not awarded any further work to Tonkin Consulting in recent times.

Walker Street - Undergrounding of Power Lines

There are 3 stobie poles on Walker Street to be removed (between Morphett and Gawler Streets). Council has been successful in gaining Power Line Environment Committee (PLEC) funding for this project (PLEC 2/3 and Council 1/3).

PLEC does <u>not</u> accept any responsibility whatsoever for any costs associated with soil contamination. Council has been engaged in lengthy negotiations with representatives of Gilbert Motors to enable the project to proceed.

In short, Council indicated that the undergrounding project would <u>not</u> proceed unless Gilbert Motors fully indemnified Council for any project costs incurred as a result of soil contamination. Gilbert Motors has agreed to provide such indemnity and a formal Deed between Council and Gilbert Motors has recently been executed for this purpose.

Next Steps

The proposed next steps are:

- 1. Proceed with the Walker Street undergrounding of power lines as a PLEC project.
- 2. Meeting with the CEO of the EPA regarding the soil contamination.
- 3. Receive and consider legal advice from TPC on the dispute with Tonkin Consulting.
- 4. Preparation of a further Council meeting agenda item.

POLICY IMPLICATIONS

1. Financial/budget

Refer to agenda item of 24 September 2008 (attachment 3).

Council is still incurring some costs through the procurement of further legal advice from TPC.

Once these latest costs are known an overall financial impact can be prepared. This will be provided in the next Council meeting agenda item referred to above under Next Steps.

2. Legal

Thomson Playford Cutlers has provided legal advice to Council on the soil contamination and their advice is awaited on the dispute with Tonkin Consulting.

Council has liaised with the EPA regarding regulatory requirements for the storage, testing, transport and disposal of contaminated soil.

3. Staffing/Work Plans

As previously advised the above processes have been very resource intensive (Council staff plus legal and other professional advice).

This has come at a considerable opportunity cost in relation to delaying some other Council initiatives.

4. Environmental

Requirements of the EPA have been satisfied.

5. Social

Public health was not threatened through the establishment of an exclusion zone during the physical works.

6. Strategic Plans

Strategic Plan

Community Assets - Objective 1

Fulfil Council's responsibility as custodian and provider of community assets.

7. Asset Management

Relocation of the stormwater infrastructure means that council now has guaranteed legal access to ensure the future management of this asset.

8. Risk Management

The risk of flooding has been significantly reduced through the upgrading and relocation of the stormwater infrastructure.

The soil contamination presents a risk, given the possibility of further migration.
