The Recruitment Panel appointed by Council has recommended the appointment of two independent members to the Summit Sport and Recreation Park Board.

Background:

- 1. The SSRP Board is a committee of Council, pursuant to the Local Government Act 1999.
- 2. The Terms of Reference for the SSRP Board require 5 members, 4 of which are independent members.
- 3. Independent Members are appointed with split terms so that the Board can maintain continuity whilst still refreshing its membership as required.
- 4. At the 6 December 2021 meeting Council approved the process to recruit two independent board members of the SSRP Board for the period 2 February 2022 to 1 February 2024.

- 5. Members of the Recruitment Panel were Mayor Ann Ferguson, Greg Parker, Executive Officer to the Board and Brian Cunningham as an independent panellist.
- 6. Advertisements for expressions of interest for 2 independent members of the Summit Sport and Recreation Park Board appeared on Council's website with a post to Facebook and an advertisement in The Courier.
- 7. Applications were due by 5 pm Monday 6 December 2021.
- 8. Seven (7) applications were received. Names of all applicants are available from the Executive Officer to the Board on request.
- 9. Current Board members, Jane Russo and Peter Scargill, whose terms are due to expire on 1 February 2022 both expressed strong interest in being reappointed and re-applied.

Discussion:

- 10. The Recruitment Panel met on 8 December 2021 and used weighted selection criteria to shortlist and determined that four (4) applicants would be interviewed.
- 11. The selection criteria used were:
 - Australian Institute of Company Directors qualifications or equivalent experience
 - commercial experience
 - local/state government experience
 - business connections
 - financial expertise
 - sports/leisure facility experience
 - contract management
 - master planning
 - marketing/community events
 - community disability/public health
 - previous Chairperson experience (included for the purposes of back-up for the Chair).
- 12. The interviews occurred on 16th of December 2021 with the following applicants (listed in no particular order):
 - Jane Russo
 - Peter Scargill
 - Jayne Symons
 - Neil Page

CVs for those interviewed are available from the Executive Officer to the Board on request.

- 13. The Council is seeking a mix of skills and the Recruitment Panel recommend the following candidates to be re-appointed to the Board:
 - Jane Russo (strengths in marketing, sports/leisure, local government, community/disability)
 - Peter Scargill (strengths in finance, commerce, sport administration)
- 14. Both Ms Russo and Mr Scargill have performed well on the Board in their 2 year terms and have made valuable contributions throughout.
- 15. As per the approved Terms of Reference for the SSRP Board the Chairperson (Iain Evans) and one independent board member (Paul Brown) were appointed for 3 years which concludes in February 2023.
- 16. Councillor Samantha Jones is currently the Council member representative on the SSRP Board and her term will conclude at the end of the term of the current Council.
- 17. Council will be asked to appoint a Council Member to the SSRP Board following the November 2022 elections.
- 18. A separate selection process will commence following the Council election in late 2022 to undertake the recruitment for the two Board positions that expire in February 2023.
