#### **Purpose:**

To endorse the Adelaide Hills Region Waste Management Authority (AHRWMA) Recruitment Panel's recommended independent Chairperson and to appoint a board member and deputy board member.

# **Summary - Key Issues:**

- o AHRWMA have concluded an interview process for the independent Chairperson under the new Charter and is seeking endorsement of the recommended applicant from each constituent Council.
- o Each constituent Council is required to appoint a Board Member and Deputy Board Member.

#### **Recommendation:**

- 3. Appoint Alexander Oulianoff, General Manager Corporate Services as a Board Member and Phillip Burton, General Manager Infrastructure as Deputy Board Member of the Adelaide Hills Region Waste Management Authority, for a period of two years, to come into effect on and from the date on which the Charter notice is gazetted.

That having considered Agenda Item 18.2 Confidential Report – Appointment of Adelaide Hills Region Waste Management Authority (AHRWMA) Independent Chairperson and Council Board Member and Deputy Board Member, in confidence under 90(2) and 3(a) of the Local Government Act 1999, the Council pursuant to Section 91(7) of the Act orders that the Council report and minutes be retained in confidence (other than the identity of Council's appointments) until the Authority's public release of the name of the Independent Chairperson or gazettal notice of the Adelaide Hills Region Waste Management Authority Charter (whichever is the sooner).

### **Background:**

- The Adelaide Hills Region Waste Management Authority is a regional subsidiary under S43 of the Local Government Act 1999 and comprising the constituent councils of Adelaide Hills, Alexandrina, Mount Barker and Rural City of Murray Bridge.
- 2. Council acknowledges the representation of the current Board Members Cr Harry Seager and Mr Greg Parker, and Cr Simon Westwood.
- 3. The Authority is governed by a Charter which was recently revised and endorsed by all constituent councils.
- 4. The revised Charter will come into effect on the date that the notice is gazetted which will occur after all board appointments have been received from constituent Councils.

### **Discussion:**

#### **Independent Chairperson**

- 5. The new Charter comprises 5 Board Members including an independent Chairperson. In accordance with that Charter:
  - One (1) person appointed jointly by Absolute Majority of the Constituent Councils, with relevant professional expertise, who is not a member or officer of a Constituent Council to be the chairperson of the Board.
  - The Chairperson of the Board shall be selected through a process determined by a panel comprising the Chief Executive Officers of the Constituent Councils.
  - The Chair is appointed for a term of 3 years, and may be re-appointed thereafter.
  - In accordance with the Charter, the Chair, will be an Independent Person
- 6. The Authority has recently undertaken a recruitment process to appoint the independent Chairperson, assisted by a qualified consultant (AM Consulting).

- 7. The recruitment panel comprised the consultant, Andrew Stuart, Andrew Aitken (Adelaide Hills Council) and Michael Sedgman (Rural City of Murray Bridge).
- 8. Six applications were received and three were shortlisted for interview. Following the interview and reference checking process the recruitment panel recommendation was unanimous in recommending Adrian Skull as the preferred candidate as he was able to:
  - demonstrate to a greater extent than the other candidates his knowledge and passion for the industry;
  - his governance experience; and
  - he possesses the interpersonal skills to under the role.
- 9. This appointment will come into effect once agreement from all constituent Councils is finalised and the Charter notice has been gazetted.

## **Board Member and Deputy Board Member**

- 10. As advised at the information briefing on this topic on 17 January 2022, the Charter also requires each constituent Council to appoint a Board Member and Deputy Board Member (to act in the place of the Board Member).
- 11. The CEO received three nominations. As per the Charter, each constituent Councils' CEO formed a panel to consider all nominations from each Council to ensure there was a good skills mix, using a skills matrix.
- 12. Following careful consideration by the Panel it is recommended that Alexander Oulianoff, General Manager Corporate Services be appointed the Board Member and Phillip Burton, General Manager Infrastructure be appointed the Deputy Board Member.
- 13. Although the Charter is silent on the term for Board Members and Deputy Board Members, their appointments are recommended for a 2 year period on and from the gazettal notice of the Charter.
- 14. The Panel's assessment of skills eventuated in recommending constituent Councils' representation on the Board comprise 1 Councillor and 3 staff members, and for Deputy Members 1 Councillor and 3 staff members.
- 15. The gazette notice of the Charter is likely to occur later in May 2022.
