#### Purpose:

To provide the outcome of the recent expression of interest process for an independent Audit and Risk Committee member following the resignation of one member in December 2019.

#### Summary - Key Issues:

- An Expression of Interest process was conducted for one independent member of the Audit and Risk Committee yielded 18 applications
- Four applicants were interviewed with one standout application.

### **Recommendation:**

Background:

1. Pursuant to section 126 of the Local Government Act 1999 ("the Act") and Regulations Council must have an Audit Committee and its membership must include at least one Member who is not a Council

member, may not include employees of this Council, and may comprise members of an Audit Committee of another Council.

2. Legislation allows a maximum of 5 Committee Members. In December 2018 Council determined to have a Committee of 5, 4 of whom are independent members.

- 3. On 20 January 2020 Council was advised of the resignation of one of the Audit and Risk Committee independent members.
- 4. Remaining independent members are Chairperson Michael Bails and Chris Howis (their terms will expire in December 2020) and Pamela Lee (her term will expire in March 2023. Council appointed Cr Hardingham to this Committee (until the end of the Council term).
- 5. The Council appointed a selection panel comprising Mayor Ferguson, the Chief Financial Officer and Risk and Governance Officer to recommend the most appropriate person for appointment.

#### Discussion:

- An expression of interest for membership of this Committee was open from 22 January 2020 – 12 February 2020. Advertisements were placed in the Courier, Australian Institute of Company Directors website, Council's website, LGA website, and Council's Facebook page.
- 7. The appointment is for a period of 4 years.
- 8. Selection criteria included experience in one or more of the following
  - Corporate governance;
  - Audit Committee or other board membership;
  - Financial management
  - Internal audit and / or risk management experience in the management of large organisations; and
  - Experience in / or understanding of local government financial management practices
- 9. Eighteen (18) expressions of interest were received during this time.
- 10. The selection panel shortlisted and interviewed four (4) of those who expressed an interest.
- 11. The Panel determined there was a standout application and following referee checks has recommended Michele Bennetts.
- 12. Michele is currently a consultant and has worked with several councils to assist with corporate governance, financial management, internal audit and risk management and wastewater. She is currently a member of three other Council Audit / Audit and Risk Committees. Her experience has also encompassed reviewing or being involved in the development of various strategic plans. Michele has also worked in organisations other than local government.
- 13. CV's of all people interviewed for this role are available as a confidential document on the Council Members' Extranet de-identified other than Michele Bennetts.
